Thursday 27th May:

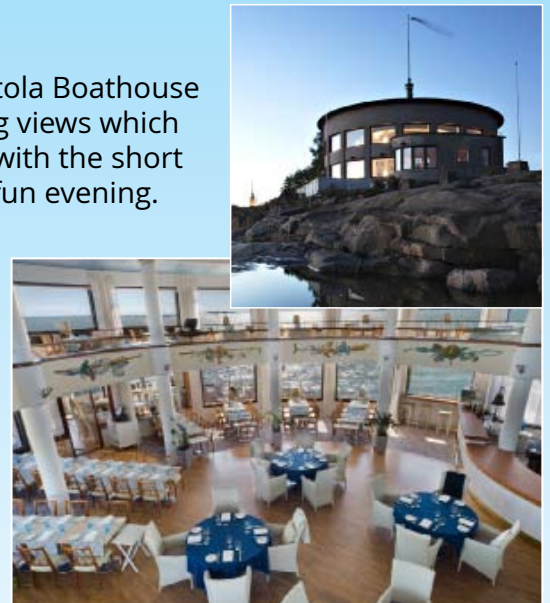
Thursday evening will be a relaxed evening for those who wish to meet for dinner and drinks in the Upper Bar at Hotel Kamp from 2000.

From here the guide will take us to some of Helsinki’s famed areas of interest:

Akseli Gallen Kallela’s Studio and home at Tarraspaa:

The beautiful surroundings and unique architecture of the Gallen-Kallela Museum provide a wonderful setting for a museum visit. The castle-like Tarvaspää studio and residence was designed and built by the artist Akseli Gallen-Kallela (1865 – 1931). Its temporary exhibitions present the art and life of Gallen-Kallela and his contemporaries and present-day works of contemporary art.

Sibelius Monument:

The Sibelius Monument is one of Helsinki's landmarks and honours Finland's national composer Jean Sibelius (1865-1957). The monument was a result of a public fund raising campaign and a two stage competition which attracted unprecedented public opinion amongst the Finnish population.



Tempelianskio "Rock" Church

The Tempelianskio "Rock" Church is a Lutheran church in the Töölö neighborhood of Helsinki. The church was designed by architects and brothers Timo and Tuomo Suomalainen and opened in 1969. Built directly into solid rock, it is also known as the Church of the Rock and Rock Church.



Senate Square

The Senate Square presents Carl Ludvig Engel's architecture as a unique allegory of political, religious, scientific and commercial powers in the centre of Helsinki, Finland.

Senate Square and its surroundings make up the oldest part of central Helsinki. Landmarks and famous buildings surrounding the square are the Helsinki Cathedral, the Government Palace, main building of the University of Helsinki, and Sederholm House, the oldest building of central Helsinki dating from 1757.



Market Square

Located in the South Harbour at the very beginning of the Esplanade Park, the Market Square is Helsinki's most international and famous market. The booths here sell traditional market foods and treats, as well as handicrafts and souvenirs.



Saturday 28th May: 1800 - 2400

Farewell Party:

The Farewell Party will commence for male delegates at 1800. The men will travel to the Katajanokan Kasino where they will begin their evening with a sauna. Our host firm have kindly offered to cover the cost of the sauna hire; the **cost to delegates will be €16.00** to cover towels and cloakroom hire. Meanwhile, the ladies may relax or enjoy sauna and spa facilities at Hotel Kamp.

We will then meet together (ladies and gents) at 1900 at Katajanokan Kasino where we can enjoy a meal –buffet Koomodori (maincourse salmon). 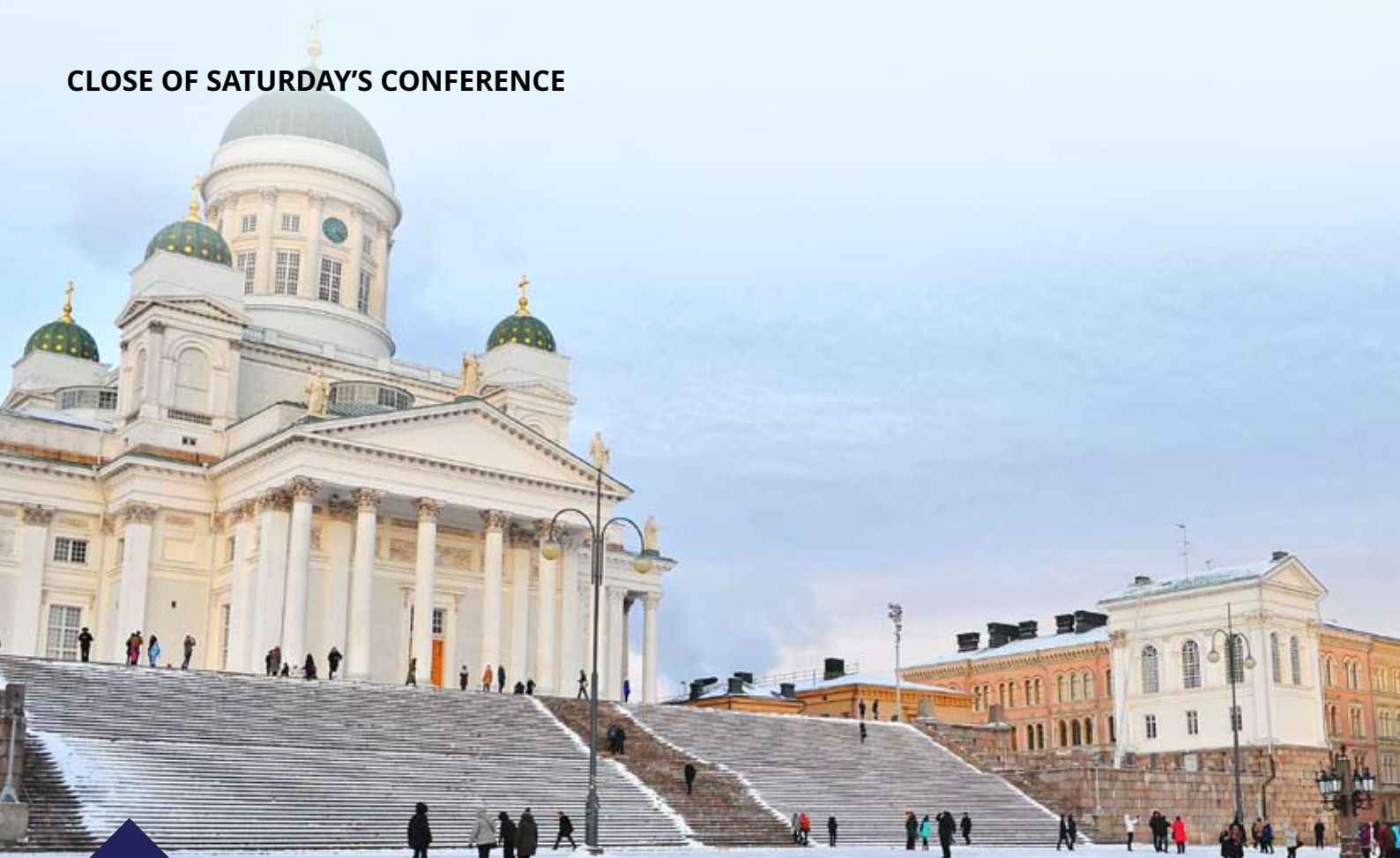
