Welcome to **SOFIA**



Dear All,

I am very much looking forward to seeing many of you in the beautiful city of Sofia. Thank you to Kostadin and his team at Manev and Partners for hosting this Autumn conference which, I am quite sure, will have the usual wonderful mix of educational discussion topics as well as a very entertaining and overflowing social agenda!

Given our strong European-centric membership, we are maintaining our focus on Europe and the issues that will affect many of us. In this conference, we are concentrating on the very live topic of Chinese Investment into Europe through Bulgaria. Adding to this, Julia Charlton of Charltons Law, our Hong Kong member will be presenting on China's One Belt Road Initiative. China's grand scheme for knitting a network of roads, ports, railways and other links from East China through Southeast and South and Central Asia all the way to Europe exceeds both in scope and ambition the Marshall Plan used to rebuild Europe after World War II. The "belt" of land-based links is paired with a 21st century "Maritime Silk Road" stretching from Australia to Zanzibar. Chinese President Xi Jinping launched the OBOR initiative in 2013, two years after then-U.S. President Barack Obama initiated the Trans-Pacific Partnership (TPP) trading bloc across the Pacific region. Now that Obama successor Donald Trump has carried out his pledge to withdraw from the TPP, the expectations are that Chinese-backed strategies like the OBOR will gain momentum.

As well as the Chinese investment into Europe, we will also be looking at the potential effect of the effect of the Bulgarian Presidency of the Council of the EU, due to commence in January 2018.

We also have a packed social agenda to unwind from the heavy discussions of the conference, which includes our usual gala dinner to take place in a highly acclaimed restaurant "Chef's Live" in one of the central City hotels, Hotel Sense. Saturday afternoon offers both wine tasting session – something that I am personally very excited about - followed by a sight seeing walking tour of Sofia, and then our farewell party with traditional Bulgarian music. Phew! I think we will all need a holiday after the weekend.

Additionally, for those of you who would wish to make some contacts through Manev and Partners for potential business opportunities in the jurisdiction, we would ask that you contact Kostadin to explore any potential meetings.
